**Sub.: Secret ballot Elections-III – Guidelines for counting of Votes-Reg.**

The procedure for counting of votes have been envisaged in Section 19.0 of Final Modalities for conduction Secret Ballot Elections (SBE-III) 2024 for recognition of Trade Unions. The following procedure has been adopted for Counting of Votes process in order to maintain a uniform procedure on South East Central railway:

1. The Votes have to be counted on scheduled date i.e., on **12.12.2024 from 08:00 hrs onwards** in a Centralized place as identified and notified by Presiding Officer.
2. Presiding Officers of the respective Divisions/Workshops/Units should **nominate** at least **Three (3) Counting officials/Teams** for **each table** for counting purpose.
3. General Secretary/Divisional Secretary/Branch Secretary of the contesting Trade Unions **will nominate One(1) "Authorized Counting Agent(ACA)" for each counting table**. Also one overall Coordinator of each contesting Trade Union for each Counting Centre may be permitted.
4. The nominated Counting Officials/Teams should report at the Centralized Counting Centre by **07:00 AM on 12.12.2024**.
5. The **"Authorized Counting Agents (ACA)"** of the contesting Trade Unions should also report by **07:00 AM on 12.12.2024**.
6. If the **Authorized Counting Agent (ACA)** do not present themselves at the appointed time and place i.e., at **07:00 AM on 12.12.2024** at the venue decided by the respective Presiding Officer during time of counting of Votes, such absence shall not invalidate the election or counting process and counting shall proceed as per schedule.
7. Presiding Officer should **arrange more number of counting tables as far as possible to ease the counting and declaring the "Total valid Votes Polled (TVVP)" immediately**.
8. The ballot Boxes should be **opened in the presence of Presiding Officers and Authorized Counting Agents (ACA)** of the Contesting Trade Unions.
9. After opening of the Ballot boxes, **number of total ballots should be tallied with the number of ballots** Box wise & Booth Wise as per the records of the Polling Officer and record pasted on the box. In case of discrepancy, record to be made in a register. **Without unfolding**, Ballot Papers to be arranged in **bundles of 50 each and if the last bundle found less than 50 the number of actual votes should be written on such bundle**.
10. Before counting of Votes begin, **the bundled Ballot Papers from all the boxes should be mixed together**. Mixing of Ballot Boxes from different booths does not mean mixing all ballots from all booths. Mixing of a reasonable number of voted ballot from boxes of different booths should be done and counting done. Same process to be repeated till all voted ballots are exhausted.

11. Presiding Officer will **distribute the bundles equally to each table.**
12. Each table should have **Seven (7) separate Compartments/Boxes/trays indicating abbreviation of the six (6) Contesting Trade Unions and One (1) Compartment/Box/Tray for invalid votes.**
13. All the **Compartments/Boxes/Trays** should be labeled with the **abbreviations of Contesting Trade Unions in bold and placed in the order of Alphabetical manner as was done in the Ballot Paper.**
14. Each **Counting Officer/Official** of the table should **open the bundle and verify the validity of votes and display the ballot paper to the Authorized Counting Agents** and drop the ballot in the respective **Compartment/Box/Tray** to which contesting Trade Union the vote is cast. In case of overlapping stamping, if the stamping is done in such a manner that **more than 2/3<sup>rd</sup> of stamp falls on any one symbol/Contesting Trade Union name or its row is to be treated as valid vote.**
15. The ballot paper contains **any indication (other than stamp) viz., name of the voter, his/her signature or any form of written message etc., is to be treated as invalid vote.**
16. Invalid votes to be declared with **reason for declaring it invalid** and shown to agents.
17. After segregating the votes casted to **each Contesting Trade Unions**, again **bundles of 50 each Valid Votes are to be made** and kept in the same **Compartment/Box/Tray** of the Contesting Trade Union.
18. On completion of making bundles of valid votes of respective Contesting Trade Unions, **counting of Total Valid Votes Polled (TVVP) should be done and recorded in a tabular form** against each Contesting Trade Union.
19. Invalid votes are also to be **bundled in 50 each** and recorded their count accordingly.
20. After counting of votes on each counting table the votes secured by unions may be advised to RO/PO & representatives of contesting Trade Unions by Asstt. Presiding Officer on hourly basis.
21. On completion of entire process of counting, the details of votes secured by each Contesting Trade Union is to be **compiled and a final summary list is to be prepared by Presiding Officer and sent of Returning Officer in the prescribed Annexure issued by Railway Board.**
22. The Presiding/Assistant Presiding Officer shall **grant Special Casual Leave to authorized Counting Agents (ACAs)** for counting of votes on counting days.
23. PO to send properly tabulated results and report on **aberrations** if any at any stage of election.
24. In case of any dispute while counting, **decision of Presiding Officer shall be final.**
25. Mobile Phones will not be allowed with anyone inside the counting centre, except for RO, ARO, PO, APO, Postal Ballot Officer & Counting Officer(Gaz.).

The above procedure should be followed scrupulously while counting the votes on the scheduled day of counting i.e. on **12.12.2024.**
