

**Sub: - Applicability of Rule 5 & 6 of RS(RP) Rules, 2016 in case of Senior Section Officer (Accounts), Senior Travelling Inspector (Accounts) and Senior Inspector (Store Accounts) granted Level-9 (non-functional basis) in terms of Board's letter RBE No. 39/2021 dated 21.06.2021.**

Please refer to Board's letter RBE No. 39/2021 dated 21.06.2021 (F. No. PC-VII/2021/I/I/2) regarding grant of Level-9 of Pay Matrix (PB-2/GP-5400) on non-functional basis to Senior Section Officer (Accounts), Senior Travelling Inspector (Accounts) and Senior Inspector (Store Accounts) on completion of 04 years service in Level-8 (PB-2/GP-4800) on the recommendation of 7<sup>th</sup> Central Pay Commission.

2. Subsequent to issuance of the letter RBE No. 39/2021, few field units sought clarification regarding fixation of pay in respect of Senior Section Officers (Accounts), Senior Travelling Inspectors (Accounts) and Senior Inspectors (Store Accounts) who granted the upgraded pay scales of Level-9 on non-functional basis in terms of letter RBE No. 39/2021.

3. Above issue has been examined and referred to Ministry of Finance. Ministry of Finance after examination, have advised to switch over to such employees from 6<sup>th</sup> CPC Pay structure to 7<sup>th</sup> CPC pay structure first and then provide the benefits of pay scale upgradation from Level-8 to Level-9 on non functional basis in 7<sup>th</sup> CPC pay structure under RS(RP) Rules, 2016.

4. Field units may take further action as per advice tendered by Ministry of Finance.
