Sub: Training Module with course content for imparting training on 'KAVACH' to running staff.

Board, in the meeting held on 24.07.2024, has decided that 'KAVACH' system to be proliferated with RDSO specifications Version 4.0 of 'KAVACH' on UHF spot frequencies.

2. Accordingly, IRISET, vide letter no. RTG/Course Calendar / 2024 dated 05.07.2024 has circulated a three-day module for training of CLIs covering various facets like working in automatic signaling territory, 'KAVACH' etc.

3. In order to cover all the running staff on 'KAVACH', a two day module is being added for detailing on 'KAVACH'. The CLIs and Instructors getting trained at IRISET may be deployed at ETCs/ZRTIs for conducting the abovementioned two day training course for the running staff attending the ETCs/ZRTIs.

4. The course content being followed at IRISET for running staff may be followed by all Zonal Railways / PUs are as under:

5	Differences between Kavach system Version 3.2 and version 4.0	
6	Kavach operation modes along with Videos.	
7	Mode transition and responsibilities of Loco Pilots.	
8	Brake Interface Unit (BIU) and Troubleshooting related to Kavach (All type BIUs).	
9	Procedure for SOS generation and reception in loco Kavach.	

10	Collision scenarios and action by loco Pilots.	
11	Recording of Kavach incidences noticed during run in CMS and Engine book.	
12	User Manual and Do's and Don'ts.	
13	Limitations of Kavach.	
14	Kavach Functionality Demonstration, DMI messages and indications and hands on training in locomotive equipped with Kavach.	

5. The course content upon any revision or changes, shall be notified to all Zonal Railways for uniformity across ETCs / ZRTI's.

6. ETCs / ZRTIs will certify the running staff of having attended and passed the course, the competency for working with '**KAVACH**' shall be accorded by CLIs after hands on training.
