The revised sports norms for recruitment of sportspersons in Indian Railways in Pay Level-1 were issued vide this office's letter mentioned under reference (iii). Some of the Zonal Railways have approached this office for review/clarification in regard to the norms for recruitment in Cricket game discipline in different pay levels.

2. In view of above, the recruitment norms for cricket game discipline have been reviewed in this office and in supersession of earlier instructions in this regard, it has been decided to revise the norms for recruitment of sportspersons in Indian Railways in the game discipline of Cricket (Men & Women) as under:
