1. Reference above, notifying Minimum and Standard Composition of Container rakes. Matter has been reviewed and the Competent Authority has decided to consolidate and revise Minimum and Standard Composition of Container rakes as under:

Type of Stock	Minimum composition for charge	Standard composition for charge
BLC	40 wagons = 80 TEUs	45 wagons = 90 TEUs
BLL	35 wagons = 70 TEUs	40 wagons = 80 TEUs
BLSS	45 wagons = 90 TEUs	48 wagons = 96 TEUs
BLLM	35 wagons = 70 TEUs	40 wagons = 80 TEUs
BLCM	40 wagons = 80 TEUs	45 wagons = 90 TEUs
BLCS	40 wagons = 80 TEUs	45 wagons = 90 TEUs
BFKN	40 wagons = 80 TEUs	45 wagons = 90 TEUs
Others	30 wagons = 60 TEUs	35 wagons = 70 TEUs

Note: i) BLC comprises of BLCA & BLCB (18 A-Car & 27 B-Car)

ii) BLL comprises of BLLA & BLLB (16 A-Car & 24 B-Car)

iii) BLSS comprises of BLSSA & BLSSB (4 A-Car & 44 B-Car)

iv) BLLM comprises of BLLMA & BLLMB (16 A-Car & 24 B-Car)

v) BLCM comprises of BLCAM & BLCBM (18 A-Car & 27 B-Car)

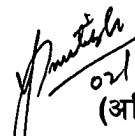
vi) BLCS comprises of BLCSA & BLCSB (18 A-Car & 27 B-Car)

3. These instructions shall come into effect from 06.01.2025 and shall remain valid till further advice.

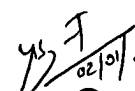

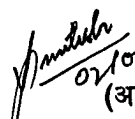
