With the approval of competent authority, the Ballast siding of Kalumna (KAV) has been opened as part of Kalumna Goods shed for outward loading of Coal under Priority-D, temporarily for three months with following conditions:

1. Since EIMWB at ET (WCR) is 307 kms away, the coal rakes loaded ex KAV to PSSS will be weighed at PTS on SECR in view of safety implications.
2. The loading party should opt for dearer route for freight payment via PTS.
