There have been instances where one (or more) set of question Paper(s) involves an error in question(s) at the printing stage or a question having wrong answer or otherwise. It has come to notice that different RRBs are adopting different methods for dealing with such cases. With a view to have uniformity by all RRBs in such cases, please note that in future, wherever, any question(s) in the question paper(s) is found to be incorrect, the question(s) may be omitted from the scope of evaluation instead of giving grace mark(s) and raw score may be assessed on percentage basis. For example, there are total 100 number of questions and one question is wrong, only marking of 99 questions be considered and the marks obtained may be proportionally equated to the marks of 100 questions followed by necessary normalization process.

Sub: Procedures to be adopted for evaluation in Departmental selection having 110 MCQ, if some of the questions are incorrect.

Ref: Sr DPO/BSP's letter No. E/GA/BSP/CONF/2022/01 dtd 23.06.2022.

1. Vide letter under reference, the discrepancy while evaluating the answer sheets of departmental examination after implementation of Board's instructions circulated vide RBE No. 59/2022 (Estt Rule No. 142/2022) was referred. It has been pointed out that in RRB examinations, all questions are compulsory, whereas in departmental questions, there are optional questions of Rajbhasha. Hence, the instructions for evaluating answer sheet after omitting wrong questions (if any) may not be implemented properly.
2. In this regard, attention is invited to Board's instructions dtd 28.11.2022, circulated vide Estt Rule No. 328/2022, clarifying the similar issue in cases of promotion from Group 'C' to 'B'. It has been decided to follow these instructions in cases of promotion within Group 'C' or from erstwhile Group 'D' to 'C' also.
