1. In terms of Corrigendum No. 06 to Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of various Container wagons in Annexure IC of Corrigendum No. 97 have been notified up to one decimal place.

2. The PCC of BLCS wagons has been reviewed and the Competent Authority has decided to revise the PCC of BLCS wagons.

Accordingly, S.No. 10 and 11 in Annexure IC of the Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0 shall be revised as under:

5. This issues in consultation with Traffic Transportation, Mechanical Engineering Directorates and with the concurrence of Finance Directorate of the Ministry of Railways.

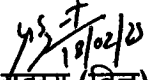

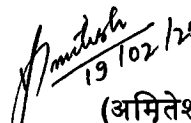
