Sub: Extension of timelines for completion of pending APAR for the year 2023-2024.

Ref: Board's letter of even number dated 15.05.2024 and 01.08.2024.

Vide Board's letter under reference timelines for completion of APARs for the year 2023-2024 through HRMS was issued. As per the timelines, entire process was to be completed by 31st December, 2024.

- 2. It has been observed that on expiry of the timeline around 25000 APARs are pending across various field units at various levels. After careful consideration of the pendency position, in order to obtain maximum finalization of APARs, it has been decided by the Competent Authority to extend the timeline for finalisation of the APARs pending at reviewing and accepting stages till **January**, **31st 2025**. There will be no extension for timelines in respect of pending APARs at self appraisal stage and reporting stage.
- 3. All field units may take necessary steps to ensure that the pending APARs are completed within the extended timelines. It may please be noted that no further extension of timelines will be granted.
