Sub: Commercial notification for induction of 54 BTAPM1 wagons with 01 BVCM for transportation of Fly Ash by M/s Dalmia Cement (Bharat) Limited (DALM) under LSFTO Scheme.

1.0 Railway Board vide their letter under reference had communicated approval for plying of two rake of BTAP wagons with 4% spare wagons including 01 (one) matching brake van under Liberalized Special Freight Train Operator Scheme (LSFTO) in favour of M/s Dalmia Cement (Bharat) Limited for movement of Fly Ash. The firm has submitted details of 54 BTAPM1 wagons (i.e. 51 wagons + 03 spare wagons) and one brake van. This is the 1<sup>st</sup> rake of M/s Dalmia Cement (Bharat) Limited. The approved loading and unloading point of this rake is as under:-

- 2.0 The Freight Rebate under LSFTO Scheme shall be given subject to fulfillment of following conditions:
- 2.1 The freight rebate under Liberalized Special Freight Train Operator (LSFTO) Scheme shall be allowed @ 12% of base freight rate prevailing at the time of booking.
- 2.2 The Freight rebate @12% will be granted for each loading of a rake from the date of commissioning to 20 years periods in the approved circuits under LSFTO scheme.
- 2.3 The freight rebate is admissible up front on RR at the time of booking in favour of M/s Dalmia Cement (Bharat) Limited.
- 2.4 The freight rebate will be charged for minimum composition of trainload as notified by Indian Railways from time to time for that particular commodity and classification.
- 2.5 The indent shall be for standard rake size as prescribed for BTAPM1 rake(s).

1/97272/2025 No freight will be charged for movement of empty rake to the next destination provided the distance travelled by empty rake is less than or equal to the distance travelled by the train before unloading. However, if the distance travelled by the empty rake is more than the loaded distance, then empty freight rate shall be charged at 50% of loaded freight of public tariff on carrying capacity of the wagons for additional distance travelled by the empty rake over and above the loaded distance.

- 2.7 The firm has opted for charging freight on trip to trip basis for movement of empty rake.
- 3.0 Maintenance of the wagons will be undertaken by IR at its own cost after commissioning of rake and till the currency of agreement. However, in case of wagons which require special components for maintenance, a provision has been made in the Registration Agreement so that the cost of procurement of such special components is defrayed by the investor.
- 4.0 The haulage charges for moving the wagons in rake formation from a private terminal to the workshop/maintenance depot/train examination point of the railway administration and back to the loading point shall be borne by the Railway Administration. In case the SFT rake has to be hauled to the nominated location for the purpose of examination, the same shall be done without charging of any haulage charge from the SFTO.
- 5.0 All payments on the RR shall be made through e-payment and online payment including Freight etc. through TMS.
- 6.0 SFTO shall be responsible to pay all charges and surcharges, fees, cess, duties, taxes etc. as payable on the basis of notification issued by the Central and State Governments from time to time.
- 7.0 The list of wagons are enclosed as **Annexure-I**.
- 8.0 The subject BTAPM1 rakes will be governed by the LSFTO agreement executed between this Railway and M/s Dalmia Cement (Bharat) Limited on 19.07.2024 and LSFTO Policy issued by Railway Board vide FM Master Circular/LSFTO/2020/0 (Letter No.2020/TC(FM)/04/02) dtd:16.03.2020 and corrigendum/ addendum thereto issued by Railway Board from time to time.
