### Instructions to the Applicant

## Request for Empanelment for providing consultancy services for private siding work

- 1. Applicant firm should go through the FFE document and read carefully.
- Reputed consultants having in-depth experience in consultancies related to Project development activities from concept to implementation of Siding projects with public/private sector participation may apply for empanelment for providing consultancy services for Siding Project on South East Central Railway. This panel of Consultant firms may be engaged by Siding Owners to carry out the consultancies including but not limited to feasibility survey, project development options, signing of agreement, construction supervision & commissioning of line.
- South East Central Railway will consider the applications received against this
  notification and approve the panel based on laid down criteria in this document subject
  to each consultancy firm (the Applicant) satisfying the eligibility criteria indicated in
  this document.
- 4. Cost of Document and Empanelment Fees.
  - 4.1 Cost of Document: 'FFE' document Form can be download from the SECR website (<a href="http://www.secr.indianrailways.gov.in">http://www.secr.indianrailways.gov.in</a>) from 15.04.2025 and must submit the 'FFE' Document with Rs.1000/- (Rupees one thousand only) in the form of Demand Draft in favour of PFA/SECR/BSP issued by nationalized bank, which will be non- refundable along with their Application, failing which the Application will be summarily rejected.

The 'FFE' Document Fee as above does not include the Empanelment Fee

- 4.2 Empanelment Fee: Applicants found suitable for empanelment will deposit the registration fee of Rs. 30,000/- + 18% GST (total Rs. 35400/-) for a period of 3 years (i.e. @ Rs.10,000/- per annum + 18% GST) in the form of Demand Draft in favour of PFA/SECR/BSP within one month from the date of communication for enlistment.
- 5. The applicant must have completed minimum one work in the last 03 years for suitable experience in the related field (i.e., survey and construction of private siding work) and should submit documents as mentioned in para-2 of General term & condition.
- 6. The application shall be submitted in an envelope, which shall be marked as "Form for Empanelment for providing consultancy services for survey, construction and management of private siding works" and Notice No. SECR/HQ/Engg/G-3/Consultants/25/01, dated 08.04.2025. Also, Envelope must include the documents as per check list mentioned in General Terms and Conditions, which shall be numbered serially.
- 7. The Demand Draft should not be bound directly with other documents but should be placed separately in a plastic cover. Each page of the documents shall be signed by the authorized signatory alongwith the Covering Letter and Checklist in the prescribed format attached with requisite document.

- 1. This 'FFE' is non-transferable.
- 2. The application must be submitted along with the following documents:
  - (i) (a) Copy of the certificate of incorporation issued by the Registrar of Companies, duly attested by a Notary Public.
    - (b) Ownership details of the firm, (e.g., Private Limited, Public Limited, Partnership Firm, or any other type) along with supporting documents duly attested by a Notary Public.
    - (c) Copy of GST Registration certificate and PAN Card of the firm, duly signed by the authorized signatory of the firm.
  - (ii) (a) Audited balance sheet of the firm for the last three years, along with the profit and loss account details, duly certified by a Chartered Accountant with their stamp, signature, and membership number.

All such clarifications/ information desired by SECR should be submitted in writing by the Applicant, signed by authorized signatory within 10 days of calling for such clarifications.
