Haulage Charges for 'Postal Traffic' carried in Postal Vans and in Non-Postal Vans, for the year 2024-25, was revised and issued vide Freight Marketing Circular No. 08 of 2024 dated 11.03.2024.

Ministry of Railways have decided to revise the Haulage Charges for 'Postal traffic' carried in Postal Vans and in Non-Postal Vans for the year 2025-26 as under:

Distance Slabs	Haulage Charges for the Postal traffic (2025-26) (in ₹ per berth per km)
0-500 km	₹1.25
501-1,000 km	₹0.79, subject to minimum realization of Haulage Charges applicable on distance of 500 Kms. (subject to minimum of ₹625)
1,000 km and above	₹0.66, subject to minimum realization of Haulage Charges applicable on distance of 1,000 Kms. (subject to minimum of ₹790)

- 2. Point to point charges shall be rounded off to the next multiple of five.
- 3. Other terms and conditions mentioned in the letter dated 19.02.2007 as revised from time to time for charging of postal traffic, billing and payment shall remain unchanged.
- 4. This issues with the concurrence of the Finance Commercial Directorate of Ministry of Railways.
- 5. Necessary instructions may be issued to all concerned immediately.
