Ref:- Secretary/DFS's DO letter No. FX-1/3/2024-PR dated 18.2.2025 &03.04.2025

Attention is invited to Para 12 of Notification no. FX-1/3/2024-PR dated 24.01.2025 regarding implementation of UPS w.e.f. 01.04.2025 adopted vide Board's Letter No. F(E)III/2025/UPS/1 dt 18.03.2025 (RBE no. 22 of 2025) which envisages that the past retirees under NPS are also eligible to opt for UPS subject to conditions specified therein.

In this connection, MoF(DFS) has also issued directives for smooth and time bound processing of cases of past retirees (copies enclosed)

It is advised that all concerned officers viz. DDOs and PAOs and the staff assigned with this work be sensitized accordingly. A suitable mechanism may also be put in place to monitor the progress made in this regard. In this connection, M/s. Protean is also updating the list of PRANs for which migration requests have been initiated and are currently pending verification and authorization at the DDO and PAO levels at regular intervals.

Please refer to my earlier D.O. No. FX-1/3/2024 dated 18.02.2025 on implementation of Unified Pension Scheme (UPS) wherein indicative list of past retirees under NPS was shared for sensitization purposes. I would like to inform you that option to migrate to UPS from NPS is active now. Already some subscribers under NPS have exercised the option of migrating to UPS.

2. Pension Fund Regulatory & Development Authority (PFRDA) has issued PFRDA (Operationalisation of UPS under National Pension System) Regulations, 2025, on 19th March, 2025, which lay down the framework to operationalise the UPS. PFRDA/Central Recordkeeping Agency (CRA) has communicated detailed Standard Operating Procedure (SoP) to NPS subscribers on manner of exercising UPS option., DDOs and PAOs of all the Ministries/Departments have also been informed about SoPs to be used under UPS. They are also available on <https://www.npscra.nsdl.co.in/ups.php>.

3. For ensuring smooth rollout of UPS, PFRDA will also be organising webinars for DDOs and PAOs. PFRDA will be conveying the schedule of webinars separately. May I request you to kindly issue directions to concerned officials of your department to mandatorily join these workshops and webinars being organized by PFRDA. PFRDA is also creating a contact center and helpline number for addressing any operational issues faced in migration process. Details of the same will be shared shortly by PFRDA. These may be extensively used.

4. Process of migration to UPS involves verification of subscriber application by DDO and PAO. It is requested to issue directions for processing all such applications in a reasonable time frame. Processing of migration requests may kindly be regularly monitored at a senior level.
