Item No. 1.9.3.4 of the Report No. 05/2024 issued by CAG for the year ended March 2022 is on Management of Health Services in Indian Railways and is regarding irregular payment of Non-Practicing Allowance to Doctors/Medical Officer holding Administrative post. In this regard CAG has advised that MOR may issue a formal order on admissibility of NPA to IRHS Doctors holding administrative posts.

A reference received from ER on the issue of admissibility of NPA as per the criteria laid down in letter under ref (i) to IRHS Doctors holding administrative posts as mentioned in letter under ref (ii) has been examined in consultation with Health Directorate and Finance Directorate of Railway Board and ER was accordingly apprised vide Board's letter dated 07.02.2023 that since IRHS Officers holding administrative posts perform clinical duties as well, besides administrative responsibilities, thus, IRHS Officers working in administrative posts mentioned in Board's letter dated 20.09.2018 are entitled for NPA. In compliance of CAG's advice, Railway Board's letter dated 07.02.2023 is forwarded herewith.


