General Terms and Conditions:

- 1. This form may be obtained by hand or downloaded from www.secr.indianrailways.gov.in. It must be submitted along with a Demand Draft of Rs.5000/- (Rupees Five Thousand only) for 'Cost of Application' issued in favour of 'Principal Financial Advisor, South East Central Railway' payable at Bilaspur (CG).
- **2.** Application form not accompanied with 'Cost of Application' will summarily be rejected. The 'Cost of Application' once paid will not be refunded under any circumstances.
- **3.** This form is available free for Small Scale Industries Unit's applicant registered with National Small Industries Corporation (NSIC). However, valid certificate should be enclosed with the application.
- **4.** Application should be submitted on the prescribed form. The application form is not transferable.
- **5.** Each application form is valid for one category of product. Applicable Product categories is mentioned in Annexure-I. Maximum 5 products of a category will be considered for approval under a single application. One product may be registered up to three packaging sizes.
- **6.** A company / firm can submit multiple applications for shortlisting of more products.
- 7. Firms applying for shortlisting should fulfill all the eligibility criteria.
- **8.** Following non-refundable Registration fee for each application (each category of product) to be payable by the applicant only after the shortlisting of their Brands / products:
 - (i) For Product Category 'A': Rs. 2,40,000/- (Rupees Two Lakh Forty Thousand only).
 - (ii) For Product Category 'B': Rs. 2,00,000/- (Rupees Two Lakh only).
- **9.** Applicable GST @ 18% as forward charge basis on Registration fee required to be deposited by successful applicant along with above Registration fee.
- **10.** Demand Draft should be issued in favour of "Principal Financial Advisor, South East Central Railway" payable at Bilaspur (CG). Registration fees once paid will not be refunded under any circumstances.
- **11.** The non-refundable registration fees are payable within 10 days after the intimation of approval of shortlisting of the Brand/products.
- **12.** The approval of shortlisted Brands / products will be valid for a period of two years only from the issuance of approval letter.
- **13.** Performance Guarantee amount Rs.50,000 /- (Rupees Fifty Thousand only) for two years (i.e. valid till currency of the tenure of shortlisted PAD Brand/products) should be deposited by successful applicant. This performance guarantee will be returned after successful completion of tenure.

- **14.** Railway Administration reserves the right to reject any application at any point of time without assigning any reason.
- **15.** Railway Administration's decision on Shortlisting of Brand / products shall be final and binding.
- 16. This process is for granting permission for supply of PAD brand catering products to the licensee operated minor static catering units under jurisdiction of SECR. The applicant will directly deal with the licensee and Railway Administration does not guarantee any specific or minimum sales volume. Further, Railway Administration will not be responsible for any dispute between the applicant and the licensee.
- **17.** Railway Administration reserves the right to collect samples of the products and getting them examined in the laboratory.
- **18.** Railway Administration reserves the right to inspect the production units of the applicant, as and when deemed necessary.
- 19. Railway Administration reserves the right to take punitive action, including imposition of penalty/ blacklisting/ debarring/ revoking permission granted temporarily or permanently as deemed necessary based on seriousness of the case, in case irregularities/complaints found for a particular product. The approval of shortlisting is also liable to be summarily terminated in view of unsatisfactory services, non-submission of required certificates like FSSAI /other applicable licenses or any other improper act by the applicant. In case any kind of irregularity found for a product, the product will be liable to be banned for sale over SECR.
- **20.** Railway Administration reserves the right to revoke permission Granted/cancel the approval temporarily or permanently as deemed necessary due to any changes in policy or any other reason. Prior to revoking permission/ cancelling the approval, a 15 day notice will be served to the applicant.
- 21. The applicant must have valid FSSAI Central License / Other statutory license certificate as the case may be. The sale of products should be within the validity period of FSSAI / Other statutory license etc. In case the validity of any such certificate expires, the sale of such products is prohibited until renewal of such license/certificate. Copy of valid FSSAI Central License / Other statutory license as applicable must be submitted to this office within 15 days of expiry of previous license.
- **22.** All packaging and labeling confirms the FSSAI/Other Statutory norms as per extant rules of Government of India for packaging and labeling.
- **23.** Quantity and MRP of product for which shortlisting is sought should not vary with the State/Local market. For sale at stations Higher MRP / Lower Grammage as compared to general market is prohibited. Printed/ Stamped remark on package of product like 'Specially Packed for sale at Railway stations' is also prohibited.
- **24.** No special packing in terms of weight, rate, etc. will be done for supply in Railways. The weights and prices as applicable in open market shall only be made available unless specifically requested for special packaging by Railways.

- **25.** Revision of Quantity/MRP for the approved item wherein rates of product to be enhanced will not be considered during the currency of approval.
- **26.** Any downward change of MRP for the approved item for the same packaging size must be intimated to PCCM office well in advance.
- 27. Applicant should sign all pages of Suppliers' Registration Form with seal. Application must be signed by Proprietor/Partner/Director or any person authorized on their behalf by Proprietor/Partner/Director and in case of Company, authorized by Board Resolution. Applicant must submit copy of PAN Card of authorized signatory. Authorised signatory is not required in case of sole proprietorship firm where application signed by sole proprietor himself.
- **28.** The mode of application is offline only. Applicants needs to submitted filled application form along with requisite documents and 'Cost of Application' at the address mentioned in form.

Mandatory Documents / Essential Criteria:

- 1. Certificate of Registration: The company/firm should be registered for manufacturing and selling products in India and should possess at least 2 years experience of manufacturing the PAD products in India.
- **2. Product's Category:** Product Category (As mentioned in Annexure-I of the Application Form) for which shortlisting is sought should be given.
- **3. Trade Mark Certificate:** Copy of Trade Mark Certificate issued by Trade Marks Registry for which shortlisting is sought should be submitted.
- **4.** Name and full address of the Manufacturer: Name and full address of the applicant's Office & Manufacturing unit(s) along with contact details should be given by the applicant. Name & Full address of firm should also enclosed on letter head.
- **5. Status of the applicant:** Copy of the Incorporation Certificate / Partnership deed / Memorandum of articles & Articles of Association etc. as applicable should be enclosed.
- **6. Certificate of Authorised signatory**: Authority letter (in case of Proprietary & Partnership Firm) or Board Resolution (in case of company) authorizes to sign application. Applicant must submit copy of PAN Card of authorized signatory. Authorised signatory is not required in case of sole proprietorship firm where application signed by sole proprietor himself.
- 7. Turnover from sale of Food & Beverage items: Copy of Audited Balance sheet, Profit & Loss account or a published report and CA's certificate specifying Firm's annual turnover from sale of Food & Beverage items, for the last two completed financial years should be submitted. The Firm should fulfill Financial Eligibility Criteria as mentioned in Annexure –I of the application form for the each preceding last two completed financial years on the date of application.
- **8.** Turnover from sale of Specific Category of Product: Copy of Audited Balance sheet, Profit & Loss account or a published report and CA's certificate specifying Brand's annual

- turnover from the sale of Specific Category of Product for which Shortlisting is sought, for the **last two completed financial years** should be submitted. The Firm should fulfill **Financial Eligibility Criteria** as mentioned in **Annexure** –**I** of the application form for the each preceding last two completed financial years on the date of application.
- **9. Valid license issued by the Competent Authority:** Copy of valid FSSAI Central License / Other statutory license as the case may be issued by the Competent Authority should be submitted.
- **10. Product's Test reports**: Copy of Test Report from a Government approved / NABL Accredited Laboratory, not older than 6 months, certifying that the product (s) is / are fit for human consumption for food items and that the product confirms to specifications and standards as per applicable norms. Test Reports for all brands / products & varieties for which shortlisting is sought to be submitted.
- **11. Details of the testing facilities available**: Details of the in- house / Outsourced testing facilities available in the factory / plant to be submitted on letter head.
- **12. Solvency Certificate**: Solvency Certificate from a scheduled bank not older than one year.
- 13. PAN Card: Copy of PAN card.
- **14. GSTIN:** Copy of Certificate of Registration under GST.
- **15. Affidavit**: An Affidavit as per Annexure –II executed by the applicant / authorised signatory should be submitted **in original** on Rs.500/- non judicial stamp paper duly Notarized.
- **16. Distribution network:** Details of national / regional distribution network. Enclose list of authorized distributors / dealers particularly covering the major stations under the jurisdiction of SECR.
- **17. Documents to be submitted by Small Scale Industries (SSI) Unit:** (i) Certificate issued by National Small Scale Industries Corporation Ltd. (NSIC) for registration as SSI Unit, to manufacture the particular Brand of F&B item. (ii) Performance report / Purchase Orders of various supply orders executed, through GeM, other Organization(s) of Reputation.
 - To avail application fee waiver, valid certificate for SSI Units registered with NSIC should be enclosed with the application.
- **18. Particulars of the Product (s)**: Particulars of the product (s) for which shortlisting is sought to be filled as per para 18 of the Application Form.
- **19. Specification of the Product (s) :** Scanned image / catalog of product showing the complete description on product viz. name, MRP/Quantity, Description, certification etc. should be attached with application.
- **20. Details of supplies made:** Details of supplies made to reputed firms / supply orders during the last two completed financial years may be enclosed.
 - If the brand / products of applicant firm shortlisted by Indian Railways / IRCTC, the copy of the same may be attached.

- **21.** Application submitted should contain all the pages of application. Information desired in all fields are essential, applicants must comply with the corresponding query. If the space provided is not sufficient, the applicant may attach extra sheet(s). Applicants should fill all fields. If the field is not applicable, write 'Not Applicable'.
- **22.** All the details must be given along with required supporting documents duly self attested by applicant. Application received without requisite documents will be summarily rejected.
- **23.** All pages of the notification & application form must be signed by the applicant with seal. **Mandatory documents and supporting documents must be self attested with seal.** The original documents may be called for verification as and when required.

Arbitration Clause:

- i) Any dispute with regard to the difference or claim arising out of this agreement shall be referred to a sole arbitrator who shall be appointed by the General Manager, South East Central Railway, including the in- charge General Manager/ Additional General Manager. The arbitrator to be appointed shall not be the one who had an opportunity to deal with the matter to which the contract relates. In the event of the arbitrator dying, neglecting or refusing to act or resigns or being unable to act for any reason, or his award being set aside by the court for any reason, it shall be lawful for the General Manager, South East Central Railways, including the in- charge General Manager/ Additional General Manager, to appoint another arbitrator in his place. The venue of all arbitration proceedings shall be Bilaspur (CG). The existence of any dispute or difference or the initiation or continuation of the arbitration proceedings shall not postpone or delay the performance by the parties of their respective obligations pursuant to his agreement. Where the arbitral award is for the payment of money, no interest shall be payable on whole or any part of the money, for any period till the date on which the award is made. The provisions of Arbitration and Conciliation Act 1996 read with Arbitration and Conciliation (Amendment) Act 2015 and rules framed in this regard by Ministry of Railways, Railway Board, New Delhi as amended from time to time shall be applicable to the arbitration proceedings"
