- 1. Reference above, BOXNHL25T wagon was included to operate over 25T Axle Load Routes for commodity Iron Ore (all types). Further, commodities Limestone, Bauxite, Slag and Clinker included for loading in the wagon.
- 2. In terms of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of various wagons have been notified up to one decimal place.
- 3. Matter has been reviewed and the Competent Authority has decided to include the loading of Gypsum in BOXNHL25T wagons over 25T Axle Load Routes. Accordingly, S.No.1 of Annexure-I (A-Open Wagons) on Page 3 of the Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0 shall be revised as under:

- 2. In terms of reference (i) above, General Managers are empowered to approve running of CC+8 operation. Other conditions and procedures shall remain same.
- 3. Eastern Railway has forwarded proposal with due approval of General Manager to include route in the list of already identified CC+8 route as below:

- 4. Matter has been examined and sanction of the Competent Authority is hereby accorded to include the above referred route of Eastern Railway in the list of already identified CC+8 routes subject to maximum permissible speed of 50 kmph. This speed limit can be reviewed by the Zonal Railway and may be revised as and when required.
- 5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
- 6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
- 7. These instructions shall come into effect from 14.06.2025 and shall remain valid till further advice.
