Sub: Permission for retention of Railway accommodation at the previous place of posting –reg.

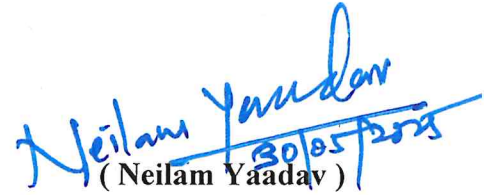
Ref: Board's letter of even No. dated 10.05.2024.

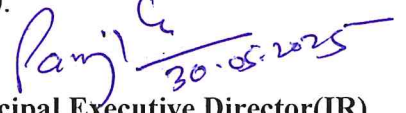
