- Reference (i) above, minimum and standard composition of various container wagons have been notified. Vide reference (ii) above, PCC and other parameters of various container wagons have been notified.
- 2. The matter has been reviewed and the Competent Authority, in partial modification to the referred corrigendum (i) above, has decided to revise the minimum and standard composition of BFKN/BFKHN wagon as under:-

Type of stock	Minimum Composition for charge	Standard composition for charge
BFKN/BFKHN	40 wagons=80 TEUs	41 wagons = 82 TEUs

- It has also been decided that the BFKHN wagon shall be treated as equivalent to the already running BFKN wagon for all charging purposes (refer Corrigendum cited at (ii) above).
- This shall come into force w.e.f. 24.07.2025 and shall remain in force till further 4. advice.
- This issues in consultation with Mechanical and Traffic Transportation Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
