Subject: Classification of 'Soda Ash, Soda Ash Dense, Soda Ash Light'.


1. In terms of Rates Circular no.15 of 2024, classification of Soda Ash, Soda Ash Dense, Soda Ash Light has been reduced as Class-120 w.e.f. 16.08.2024 up to 15.08.2025.


