Sub: Pilot project to increase utilization of 'JPP-RCS' services.

The Competent Authority has accorded approval for charging of discounted freight in the JPP-RCS services running on '**PTNR-CP-PTNR**' route also, as admissible in terms of FM Circular No. 05/2025, dtd. 11.03.2025.

2. Further, forward and return trip of the said JPP-RCS services shall be pre-defined in the 'Virtual Aggregation Platform (VAP)'.
3. Till the duration of the Pilot project, clause 12.2 of the FM Circular No. 02/2024 (i.e. JPP-RCS Policy) shall not be applicable.
4. These instructions shall come into force with immediate effect, and shall remain valid upto to **31.03.2026**, on experimental basis as a Pilot project. The discounted freight shall not be applicable on the bookings already done in the said JPP-RCS trains prior to issuance of this letter, and **no refund of freight** on this account, shall be admissible.
5. CRIS is requested to ensure necessary modifications in the 'VAP', including pre-defining of forward and return trip of the above mentioned JPP-RCS services.
6. Necessary instructions may be issued to all concerned. Further, all efforts may be made out for its wide publicity.
