Sub:- Grant of financial upgradation under MACP Scheme in respect of Chief Matron's Category- clarification-reg.

Ref:- 1. Railway Board's letter dated 13.12.2012 (RBENo. 142/2012).

2. Railway Board's letter No.PC-V/2009/ACP/2 dated 21.08.2014.

It has come to notice that few Railways are not following the MACP guidelines issued vide the above referred letters of Railway Board and that Chief Matrons (Grade Pay-5400/PB-3) are being allowed Grade pay 6600/PB-3 as 3rd financial upgradation under MACP Scheme even if they have been granted 2ndpromotion/2ndfinancial upgradation after 31.08.2008. In this regard, it is pointed out that the promotional post of Chief Matrons is Asstt. Nursing Officer (ANO) in the same Grade Pay of 5400/PB-3. Necessary instructions regarding grant of financial upgradation in such cases have been issued vide Board's letter dated 13.12.2012 (RBE No.142/2012) which stipulates that in such situation financial upgradation under MACP Scheme would be granted to the same Grade Pay as financial upgradation under MACP Scheme cannot be to a higher Grade Pay than what can be allowed to an employee on his normal promotion.

It is further advised that the aforementioned Board's instructions dated 13.12.2012 may be strictly followed while implementing MACP Scheme in respect of Chief Matrons category and necessary remedial action on the above lines, if any, may be taken immediately.
